EXTERIOR PAINT GUIDE

The attached Exterior Paint Guide has been provided to assist you with determining and ordering paint for the exterior of your home. This matrix has been created from the proprietary information of Peterson Painting in Livermore. Circle-E Association makes no claim nor guarantee to it's accuracy or whether using any paint listed will be an exact match. This is only provided to guide the owner in the right direction in purchasing exterior paint.

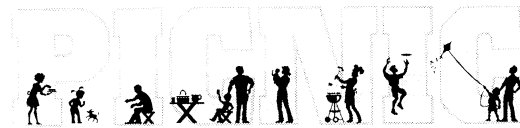
Suggested directions:

- 1) Determine your lot number
- 2) Match your lot to one of the three available schemes
- 3) Choose the series of colors most resembling your home. If you have difficulty determining your color scheme, it is suggested you contact Peterson Painting directly at (925) 455-5864. Inform them that you are an owner of a Toll Brothers home at The Orchards in San Ramon Heights and give them your lot number. They can assist you by providing the correct Sherwin-Williams paint code.
- 4) Once you've determined your paint code, head directly to the Sherwin-Williams store in Dublin on Dougherty Road. From there, you can request to see a paint chip to validate your paint selection.
- 5) Then order up as much paint as you want.
